## Important action points to be completed immediately

- Immediate correction of computerized land records in respect of all Leases and Inter-Departmental land transfers. Similarly, all acquired lands shall be updated in favour of Requiring Bodies.
- 2. Immediate reconciliation of Register X (Register of Leases) with Computerized Land Records.
- Immediate reconciliation of Register VIII (Register of Government Lands) with computerized land records in respect to the Khatian 1 and incorporation of subsequent record corrections.
- 4. Proper flagging of Tenants and Possessors for all Patta khatians in computerized land records .
- 5. Proper Tenant and Possessor flagging of 6(3)/ 4(B) /Thika /Wakaf /Tribal /14Y/ Lessee/ Homestead Acquisition in computerized land records .
- 6. Identification and correction of shares in the plots where total share is erroneously more than 10000 and Khatian 1 exists in that plot.
- 7. Regular maintenance and verification of Cash Book and GRN related treasury verification and prompt reply/ liquidation of pending audit queries .
- 8. Immediate resolution of any complaint regarding Fake Deeds and restoration of record. (vide order No. 213-1S/10/2020 dated 17.01.2020 issued by LRC)
- 9. Regular monitoring and supervision of Modern Record Rooms.
- 10. Immediate incorporation of Hal-Sabek data in mouzas where Hal-Sabek entries are pending.
- 11. Reconciliation of computerized land records (CLR) with digitized LR Map regarding last plot number.
- 12. To complete the work of framing of land records in mouzas where final publication of Record of Rights (RoR) is pending.
- 13. Correction of records where Hat, Bazar ,etc. , are still recorded in Raiyati Khatiyan (Ref: Instruction issued vide memo No. 3278(23)-1S/269/23 dated 14.08.2023 )
