Sub:- Collection of data for Land Reforms beneficiaries belonging to minority Communities.

In the present system, for the basic of land reform activities, namely, Distribution of Vested Land and Recording of Bargadars, data in respect of beneficiaries belonging to Scheduled Tribe and Scheduled Caste communities are being maintained at all level. In view of the change circumstances, it has become necessary to have data relating to such beneficiaries belonging to be Minority communities.

So far as recording of Bargadar is concerned, such data for the computerized mouzas are easily available from the computerized data-base. Manual activities in respect of mouzas yet to be computerized will be nominal in most of the districts (except Purulia) which may be taken up immediately so that data in respect of Bargadars belonging to be Minority communities may be available at the state level as quickly as possible.

So far as pattas are concerned, searching in computerized data-base will not yield the desired result as most of the pattas issued in the past were not recorded by opening separate khatians. But each and every R.I is supposed to maintain, among others, the register of pattadars in respect of mouzas falling within its jurisdiction. Collecting information from such register and then its completion at the block level may not be a very difficult task.

Instruction may be issued to the District Land and Land Reforms Officers to take up the work on top priority and send block-wary data in respect of the Bargadars within a month and in respect of pattadars within the two months.

The format for reporting data for these two items may be suitably modified so that data relating to Pattadars and Bargadar as a general system, come with a break-up showing the number of beneficiaries belonging to Scheduled Tribes, Scheduled Castes and Minorities along with the total number of beneficiaries.
