MEMORANDUM

No. 2397-M&M/LR/A-II/26/201

Dated, 9<sup>th</sup> November, 2015

Whereas a memorandum vide No. 1250-M&M/LR/A-II/M&M-26/2010 dated, 29<sup>th</sup> May, 2015, containing detailed guidelines was issued by this Department for one-time regularization of brick fields which were set up on agricultural land after 1<sup>st</sup> September, 2000, within a period of 4(four) months from the date of issuance of memorandum;

And whereas the memorandum which was to remain in force for a period of 4 (four) months from the date of issuance has already lapsed and ceased to be in force;

And whereas the owners of a large number of unauthorised brickfields spread over the districts in the State have failed to collect statutory and/or non-statutory clearances from different authorities and departments and submit applications along with requisite clearances for regularisation within 4(four) months as specified in the memorandum;

And whereas a large number of people particularly from disadvantaged section of the society and poor socio-economic conditions have been working in such brick fields for livelihood for years together and such brick fields, if have to be closed down without an opportunity of regularisation, shall render a large number of people jobless without any source of regular income to look after their families;

And whereas, if such a large number of brick fields fail to get regularised as per the said guidelines due to time constraints, the production of bricks will also severely come down and it shall have adverse impact on infrastructure and other projects;

Now, therefore, the Governor is pleased to extend the time frame for compliance of the aforesaid memorandum for a further period of 12(twelve) months with effect from 1<sup>st</sup> October, 2015 until further order.
